("Fulgent Sun", TWSE: 9802) today announced its consolidated sales of March 2021 reached a historical high NT\$1.15 billion (YoY 45.48%) of the same month (YoY 54.78% in terms of US\$). Unaudited sales for 2021 1Q hit a historical high NT\$3.42 billion (YoY 23.22%) of the same quarter (YoY 30.80% in terms of US\$). In respect of US dollars, the sales of 2021 1Q reached a historical high US\$120 million for single quarter (the second highest quarter sales was US\$113 million in 2019 4Q).

Lunar new year holidays usually lead to fewer working days in the first quarter of each year, while global shortage of containers still affected Fulgent Sun's shipment schedules. However, sales of 2021 1Q still hit a historical high, appearing to a positive industry growth trend and showing the group's operating and orders taking abilities are superior to before.

Fulgent Sun holds an optimistic prospect and values consumers' growing awareness on outdoor leisure and activities due to COVID-19. Given that orders of mass production are well allocated and production capacity increases, and with the additional energy accumulated from the group's various investments and layouts in 2020, rewards are expected to display substantially in 2021 and the coming years. The group's growth momentum seems robust in operation and management.


