

Fulgent Sun announces its unaudited sales for June 2017 was NT\$1,045 million (+MoM 8.64%,+ YoY 11.32%).

2017 2Q unaudited consolidated sales reached NT\$2,562 million

Fulgent Sun International (Holding) Co., Ltd. ("Fulgent Sun", TWSE: 9802) today announced its unaudited sales for June 2017 was NT\$1,045 million on a consolidated basis, an increase of 8.64 percent from May 2017, also an increase of 11.32 percent from June 2016. Unaudited consolidated sales for 2Q 2017 totaled NT\$2,562 million, to reach the single-season of historical high, an increase of 15.66 percent compared to the same period in 2016, but in dollar terms, the revenue growth of up to 23.70%.

Unaudited consolidated sales for January through June 2017 totaled NT\$4,919 million (In New Taiwan dollar terms, + YoY 4.96%; In US dollar terms, + YoY 12.21%). Although the revenue in June to maintain high-grade and annual growth rate of 2 digits, customers requested delivery schedule could suggest about NT\$150 million revenue deferred recognition. Fulgent Sun hold an optimistic view on 2017 Fall/Winter product shipment is expected to reach peak in July. With the Fall/winter and Spring/Summer shoes season alternately, Fulgent Sun is expected to gradually enter the shipping off-season in September and October. The single-month revenue will be lower than the single-month output value, production and sales gap is still exists, but off-season is not low. The Group's output value and sales will be higher than in previous years while the orders and capacity continued to maintain the high level, long-term growth momentum without fear.
